Penetapan Kepala Unit Internal Audit di Perseroan mengacu pada Surat Keputusan Direksi No. 007/SK/DIREKSI-HUMI/IX/2022. Fungsi Audit Internal Perseroan dilaksanakan oleh Unit Internal Audit yang bertanggung jawab langsung kepada Direktur Utama. Unit Internal Audit memiliki peran strategis dalam mendukung pencapaian kinerja Perseroan melalui proses audit. Unit Internal Audit berperan dalam pencegahan *fraud*, deteksi *fraud*, dan investigasi *fraud*. Unit Internal Audit memiliki akses langsung kepada Komite Audit untuk mengkoordinasikan dan mengelola informasi yang berkaitan dengan kegiatan dan hasil audit.

DASAR HUKUM

Penunjukan Unit Internal Audit Perseroan berlandaskan pada ketentuan POJK No. 56/POJK.04/2015 tentang Pembentukan dan Pedoman Penyusunan Piagam Unit Internal Audit HUMI dan Piagam Unit Internal Audit HUMI.

PIAGAM INTERNAL AUDIT

Dalam menjalankan tugas dan tanggung jawabnya, Unit Internal Audit mengacu pada Piagam Internal Audit yang bersifat mengikat bagi setiap anggota Unit Internal Audit. Piagam tersebut telah diperbaharui dan disetujui oleh Direksi dan Dewan Komisaris pada tanggal 1 September 2022, dan telah diunggah ke situs *web* Perseroan, www.humi.co.id. STRUKTUR DAN KEDUDUKAN KEPALA UNIT INTERNAL AUDIT

Kepala Unit Internal Audit diangkat dan diberhentikan oleh Direktur Utama atas persetujuan Dewan Komisaris. Setiap pengangkatan, penggantian, dan pemberhentian Kepala Unit Internal Audit Perseroan, wajib diberitahukan kepada OJK. Kepala Internal Audit mempunyai garis pelaporan tidak langsung kepada Komite Audit melalui pertemuan rutin untuk membahas isu-isu terkait pengendalian internal dan manajemen risiko dengan struktur sebagai berikut:

The appointment of the Head of the Internal Audit Unit in the Company refers to Board of Directors Resolution Number 007/SK/DIREKSI-HUMI/XI/2022. The function of the Company's Internal Audit is carried out by the Internal Audit Unit, which reports directly to the President Director. The Internal Audit Unit plays a strategic role in supporting the Company's performance through the audit process. It is responsible for fraud prevention, detection, and investigation. The Internal Audit Unit has direct access to the Audit Committee to coordinate and manage information related to audit activities and results.

LEGAL BASIS

The appointment of the Company's Internal Audit Unit is based on regulations, including Financial Services Authority Regulation Number 56/POJK.04/2015 concerning the Establishment and Guidelines for the Preparation of the Charter of the Internal Audit Unit, as well as the Internal Audit Charter HUMI.

CHARTER OF THE INTERNAL AUDIT

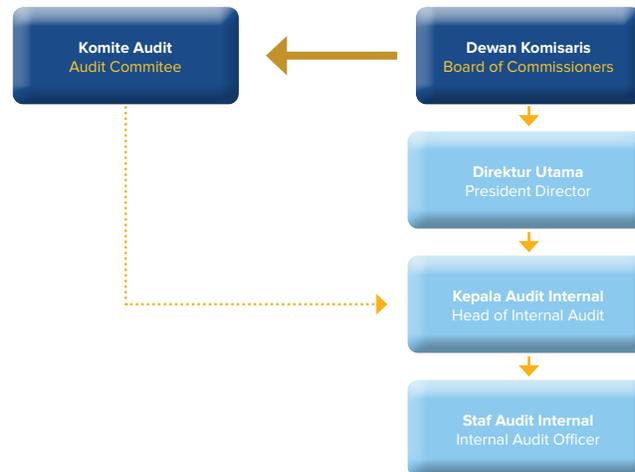
In carrying out its duties and responsibilities, the Internal Audit Unit adheres to the Internal Audit Charter, which is binding for every member of the Internal Audit Unit. The charter was revised and approved by the Board of Directors and the Board of Commissioners on September 1, 2022, and has been uploaded to the Company's website, www.humi.co.id. The contents of the Internal Audit Charter are as follows:

STRUCTURE AND POSITION OF THE HEAD OF INTERNAL AUDIT UNIT

The Head of the Internal Audit Unit is appointed and dismissed by the President Director with the approval of the Board of Commissioners. Any appointment, replacement, and termination of the Head of the Internal Audit Unit of the Company must be reported to the Financial Services Authority (OJK). The Head of Internal Audit reports indirectly to the Audit Committee through regular meetings to discuss issues related to internal control and risk management, with the following structure:

INDEPENDENSI DAN PERSYARATAN INTERNAL AUDIT

Unit Internal Audit merupakan fungsi advisor/penasihat yang mempunyai kondisi bebas dari situasi yang dapat menurunkan kemampuan aktivitas internal auditor untuk dapat melaksanakan tanggungjawabnya secara tidak memihak dalam Perusahaan. Untuk itu, Unit Internal Audit:

1. Bertanggung jawab langsung kepada Direktur Utama dan independen terhadap setiap unit kerja di Grup HUMI.
2. Tidak terlibat langsung dalam kegiatan operasional Perusahaan sehari-hari.
3. Tidak diperkenankan perangkap tugas dan jabatan auditor internal dan pelaksana dalam Unit Internal Audit dari pelaksanaan kegiatan operasional perusahaan baik di HUMI maupun Anak atau Unit usaha.

TUGAS DAN TANGGUNG JAWAB INTERNAL AUDIT

Unit Internal Audit memiliki tugas dan tanggung jawab, antara lain:

1. Menyusun dan melaksanakan Rencana Kerja Audit Internal Tahunan (RKAT).
2. Menguji dan mengevaluasi pelaksanaan pengendalian internal dan sistem manajemen risiko sesuai dengan kebijakan manajemen.
3. Melakukan pemeriksaan dan penilaian atas efisiensi dan efektivitas di bidang keuangan, akuntansi, operasional, sumber daya manusia, pemasaran, teknologi informasi, dan kegiatan lainnya.
4. Memberikan saran perbaikan dan informasi yang objektif tentang kegiatan yang diperiksa pada semua tingkat manajemen.
5. Membuat laporan hasil audit dan menyampaikan laporan tersebut kepada Direktur Utama dan Dewan Komisaris.
6. Memantau, menganalisis, dan melaporkan pelaksanaan tindak lanjut perbaikan yang disarankan.
7. Menyusun program untuk mengevaluasi *Quality Assurance* kegiatan audit internal yang dilakukan.

INDEPENDENCE AND REQUIREMENT OF INTERNAL AUDIT

The Internal Audit Unit serves as an advisory function, ensuring independence from any situation that may compromise the ability of internal auditors to carry out their responsibilities impartially within the Company. Therefore, the Internal Audit Unit:

1. Reports directly to the President Director and remains independent from every department within the HUMI Group.
2. Does not engage directly in the day-to-day operational activities of the Company.
3. Is prohibited from dual roles where internal auditors or staff within the Internal Audit Unit participate in operational activities of the Company, whether within the publicly listed company or its subsidiaries or business units.

DUTIES AND RESPONSIBILITIES OF INTERNAL AUDIT

The Internal Audit Unit is tasked with various responsibilities, including:

1. Developing and executing the Annual Internal Audit Plan (AIAP).
2. Testing and evaluating the implementation of internal controls and risk management systems in accordance with management policies.
3. Examining and assessing the efficiency and effectiveness in financial, accounting, operational, human resources, marketing, information technology, and other activities.
4. Providing objective recommendations and information about the audited activities to all levels of management.
5. Compiling audit findings and presenting reports to the President Director and the Board of Commissioners.
6. Monitoring, analyzing, and reporting on the implementation of suggested corrective actions.
7. Developing programs to evaluate the Quality Assurance of internal audit activities conducted.

RUANG LINGKUP UNIT INTERNAL AUDIT

Berdasarkan tujuan utama dibentuknya Unit Internal Audit, yaitu untuk menguji dan mengevaluasi apakah kerangka kerja proses manajemen resiko, pengendalian dan tata kelola perusahaan telah memadai dan berfungsi secara baik, juga untuk memberikan saran atau rekomendasi kepada Direktur Utama dan manajemen unit kerja untuk memperbaiki manajemen resiko, pengendalian internal dan tata kelola perusahaan, dengan ruang lingkup pekerjaan Unit Internal Audit, meliputi:

1. Pengujian dan evaluasi efektivitas pelaksanaan pengendalian internal di Grup HUMI dengan mengadaptasi *Internal Control Framework COSO (Committee of Sponsoring Organizations of the Treadway Commission)*.
2. Evaluasi terkait pelaksanaan pengendalian internal yang meliputi Lingkungan Pengendalian (*Control Environment*), Identifikasi dan Penilaian Risiko (*Identification & Risk Assessment*), Kegiatan Pengendalian (*Control Activities*), Informasi dan Komunikasi (*Information & Communication*) dan Kegiatan Pemantauan (*Monitoring Activities*).
3. Evaluasi kepatuhan kepada ketentuan dan peraturan perundang-undangan yang berlaku di kapal dan di Grup HUMI.
4. Evaluasi efektivitas kebijakan sistem dan prosedur yang berlaku di kapal, dan di Grup HUMI serta memberikan rekomendasi perbaikan.
5. Melaksanakan audit khusus/investigasi yang ditugaskan oleh Direktur Utama.
6. Memberikan konsultasi kepada Direktur Utama dan atau Pimpinan Unit Kerja untuk mendorong peningkatan kinerja dan atau ketaatan kepada ketentuan yang berlaku.

KODE ETIK AUDITOR

Kode Etik adalah prinsip-prinsip yang relevan terhadap profesi audit internal, serta aturan perilaku yang menjelaskan perilaku yang diharapkan dari seorang auditor internal. Seluruh aktivitas audit internal yang dilaksanakan Unit Internal Audit harus mengacu pada kode etik profesi auditor internal dari *The Institute of Internal Auditor (IIA)*. Unit Internal Audit harus secara konsisten menerapkan kode etik profesi sebagai berikut:

1. Integritas
Integritas auditor internal membentuk kepercayaan dan oleh karenanya menjadi dasar untuk menyandarkan terhadap pertimbangannya.
2. Objektivitas
Auditor internal menerapkan objektivitas profesional yang tinggi dalam memperoleh, mengevaluasi, dan mengkomunikasikan informasi tentang kegiatan yang dilakukan. Serta melakukan penilaian yang seimbang atas segala hal yang relevan dan tidak terpengaruh secara tidak semestinya oleh kepentingan pribadi atau oleh pihak lain dalam memberikan pertimbangan.
3. Kerahasiaan
Auditor internal menghormati nilai dan kepemilikan informasi yang diterimanya dan tidak mengungkap informasi tersebut tanpa kewenangan yang sah, kecuali diharuskan oleh hukum.
4. Kompetensi
Auditor internal menerapkan pengetahuan, keterampilan dan pengalaman yang diperlukan dalam memberikan jasa audit internal.

THE SCOPE OF INTERNAL AUDIT UNIT

Based on the main objective of establishing the Internal Audit Unit, which is to test and evaluate whether the framework of risk management, control, and corporate governance processes is adequate and functioning properly, and to provide advice or recommendations to the President Director and management of business units to improve risk management, internal control, and corporate governance. Therefore, the scope of work of the Internal Audit Unit includes:

1. Testing and evaluating the effectiveness of internal control implementation within the HUMI Group by adapting the COSO Internal Control Framework (Committee of Sponsoring Organizations of the Treadway Commission).
2. Evaluation related to the implementation of internal controls, including Control Environment, Identification & Risk Assessment, Control Activities, Information & Communication, and Monitoring Activities.
3. Evaluation of compliance with applicable laws and regulations on ships and within the HUMI Group.
4. Evaluation of the effectiveness of policies, systems, and procedures applicable to ships and within the HUMI Group, and providing improvement recommendations.
5. Conducting special audits/investigations assigned by the President Director.
6. Providing consultations to the President Director and/or Unit Leaders to promote performance improvement and compliance with applicable regulations.

CODE OF ETHICS FOR AUDITORS

The Code of Ethics comprises principles relevant to the internal audit profession, as well as rules of conduct that outline the expected behavior of an internal auditor. All internal audit activities conducted by the Internal Audit Unit must adhere to the code of ethics of the internal audit profession as set forth by The Institute of Internal Auditors (IIA). The Internal Audit Unit must consistently apply the following professional ethics:

1. Integrity
Integrity in internal auditing builds trust and is therefore the foundation upon which its judgments rely.
2. Objectivity
Internal auditors apply high standards of professional objectivity in obtaining, evaluating, and communicating information about the activities being examined. They make balanced assessments of all relevant circumstances and are not unduly influenced by personal interests or by others in rendering judgments.
3. Confidentiality
Internal auditors respect the value and ownership of the information they receive and do not disclose such information without proper authorization, except as required by law.
4. Competency
Internal auditors apply the knowledge, skills, and experience necessary in providing internal audit services.

LAPORAN KEGIATAN UNIT INTERNAL AUDIT TAHUN 2023

Sepanjang tahun 2023, Unit Audit Internal telah melakukan kegiatan pemantauan dan pelaporan pelaksanaan audit internal kepada Direktur Utama dan Dewan Komisaris. Secara periodik Unit Internal Audit telah melakukan berbagai upaya untuk memastikan implementasi audit internal baik di lingkup Perseroan maupun anak usaha.

Unit Internal Audit HUMI telah menyelesaikan 100% penugasan audit pada tahun 2023, sesuai dengan rencana penugasan awal dengan hasil kegiatan sebanyak 5 Laporan Kegiatan Audit dan 3 Kegiatan Pendampingan. Unit Internal Audit juga melaksanakan peran dalam memberikan *consultative review* dan *advisory* yang independen kepada anak usaha terkait penggunaan model keuangan Pedoman *Capital Expenditure* (CAPEX) serta penugasan tambahan dari manajemen. INTERNAL AUDIT UNIT ACTIVITY REPORT FOR THE YEAR 2023

Throughout the year 2023, the Internal Audit Unit has conducted monitoring activities and reported on the implementation of internal audits to the President Director and the Board of Commissioners. Periodically, the Internal Audit Unit has made various efforts to ensure the implementation of internal audits within the Company and its subsidiaries.

The Internal Audit Unit of HUMI has successfully completed 100% of its audit assignments in 2023, in line with the initial assignment plan, resulting in 5 Audit Activity Reports and 3 Advisory Activities. Additionally, the Internal Audit Unit played a consultative and independent advisory role to subsidiaries regarding the utilization of the Capital Expenditure (CAPEX) financial model and undertook additional assignments from management.
